Dear Members,

Thank you for being a member of iTHINK Financial Credit Union. We know 2021 certainly had many challenges and difficulties. We want you to know that you are a valued member and owner of your Credit Union. We are here for you anytime, but especially in your time of need. You have many options for your financial services, and we appreciate you trusting us with this great responsibility.

Despite the turmoil of 2021, your Credit Union had another strong financial year. We increased total assets nearly 10% up to \$1.870 billion. We originated \$775 million in loans, an increase of 18% over 2020, as we strived to meet all your personal and business loan needs. With that loan growth, our income was strong, and our net worth position is stable. Our net worth ratio is 10%, which keeps us in the "well-capitalized" category with nearly \$183 million in reserves. Our loan delinquency and net charge-off ratios are excellent by industry standards. No matter the numbers, our mission is to make sure we take care of YOU, the member.

Financially, YOUR Credit Union is a very sound financial institution. Unfortunately, there are areas out of our control; cyber-attacks, security breaches, or a member's identity being stolen remain a primary concern and areas we approach with constant vigilance. We are working hard to continue keeping your identity and your personal data safe and secure. We pledge to continue improving our systems to maintain the highest level of security. Maintaining your trust by protecting your hard-earned money is another way we say thank you for using YOUR Credit Union.

Our pledge to you this year is that we will continue to improve our services. Our 2022 goals include maintaining a safe and clean environment for you to perform transactions in person. We are also improving our digital channels, Online and Mobile Banking, so you can continue to do ALL your business in the comfort of your own home or wherever you are.
